

How to Register

Complete the Registration form and enclose your payment. Mail to the address on the form. The form may be duplicated if needed.

Payments, Cancellations and Refunds

Full payment is due at the time of registration. The deadline to register is Friday, May 12, 2017, **or until filled**. Space is limited to 25. Calling the office to state your intention to participate does not guarantee a seat. Participants are enrolled as payments are received. Payment must be received by the deadline. If the class is full when you register, you will be added to the waiting list for the next class. **No refunds will be made for cancellations**, but substitutions may be made in advance of the first day of class by contacting the Extension office.

Lunch

You will receive at least 45 minutes for lunch each day. There are several quick-service restaurants within a 5-minute drive. If you choose, you may bring a bag lunch. Drinks and snacks will be provided both days.

SERVSAFE Certification Training

Participants are trained and tested for certification through the *ServSafe Manager 6th edition* book. **The class is taught in English and materials are written on an 8th grade reading level.**

The course will cover the latest information in food safety, including personal hygiene; how to use food thermometers and keep temperature logs; how to prepare, store, cook, hold, cool, reheat and serve food safely; and methods of cleaning and sanitizing.

Compliance with Food Safety rules

North Carolina's adoption of the Federal Food Code requires the presence of a "Person-in-Charge" with food safety certification that can demonstrate food safety knowledge and active managerial control. ServSafe certification will help food service establishments meet this requirement.

First time certification

We offer a two-day class and exam for those who have never been certified. After your payment is received **you should pick up your book and study materials so that you may begin reviewing them before the class begins.**

Independent study Option

If you are confident in your ability to study on your own, you may purchase a book and study packet. If you choose this option it is your responsibility to make sure you have time to study. You may participate in the review and take your exam on the second day with the class or you may arrange to take the exam on another date (**contact the office for alternate dates**). You still have the option of attending the full class if you change your mind. After your payment is received, **you may pick up your book and study packet at the Extension office.**

Recertification or Retest

For those who do not need the full class but need to recertify, we strongly recommend the review session prior to taking the exam. For persons who previously took the exam, but did not pass, we also recommend the review session. You may request a study packet. Review sessions will be held during the second day of class or two hours prior to other scheduled exams. **If you plan to take the exam on the second day of class**, plan to arrive by 8:30 a.m. to participate in the review before taking the exam. If you do not wish to participate in the review session, check in by 12:30 p.m.

Training Location

This training will be held at the Iredell County Agricultural Resources Center located at 444 Bristol Drive in Statesville. From I-40 take Exit 148, travel east on US 64 & 90 to the second traffic light, turn right onto Bristol Drive and go .3 miles to the building on the right. From I-77 take Exit 49-A, west on Garner Bagnal Blvd., travel 4.3 miles to traffic light and turn left onto Bristol Drive.
